### **WHAT ARE AGNICO EAGLE'S GENERAL FUNDING OBJECTIVES?**

We demonstrate our commitment by supporting events and causes that:

- Support initiatives with an Environmental focus (Avativut).
- Promote Inuit Culture and Tradition (Tunnganarniq), fostering positive relationships by being open, welcoming and inclusive: this includes events and causes that promote a sense of community.
- Support Development/Capacity Building by involving Qanuqtuurungnarniq and Pilitiqatigiingniq to build capacity within communities for a self-sustaining future.
- Promote Well-being (Inuuttiarniq) by fostering community wellness and encouraging a healthy and active lifestyle.

### **WHAT ARE THE PRIORITIES SUPPORTED BY AGNICO EAGLE VIA THE SOCIAL INVESTMENT PROGRAM?**

To help ensure that our social investments have the greatest positive impact, Agnico Eagle prioritizes social investments in wellness areas that have been chosen by our surrounding communities, specifically:

Requests are reviewed upon reception. If your request is approved, please allow 45 days for the funds to be provided after receiving payment information.
