APPENDIX 37-1. 2024 KIVALLIQ ELDERS ADVISORY COMMITTEE SUMMARY REPORT

INTRODUCTION

In 2021, Agnico Eagle established the Kivalliq Elders Advisory Committee (KEAC), a group which provides invaluable guidance to Nunavummiut and our Nunavut operations teams.

Comprised of Elders from the communities of Baker Lake, Chesterfield Inlet, Rankin Inlet, Whale Cove, and Arviat, the Elders' Committee not only keeps local communities informed about Agnico Eagle's mining activities and future plans, but it also provides Inuit Qaujimajatuqangit and Inuit Qaujimaningit (IQ), a body of Inuit traditional knowledge (TK), and Inuit Societal Values (ISV), a set of guiding community principles, so that it can be integrated into our exploration, planning, workforce, wellness, operational and closure plans.

In 2024, the committee actively participated in 9 meetings, 2 site visits and 12 initiatives. More information about those activities is provided below.

- The elders were glad to learn about examples of local businesses that have been supported by the mentoring program. They have encouraged Agnico Eagle to further pursue advertisement of those initiatives to inspire the younger generation.
- Traditional knowledge was shared regarding closure and reclamation of the Meadowbank Mine site.
- Elders visited the Meliadine Mine site and had lunch with friends and family at the mine complex.

Initiatives

Leadership Development Program, Cultural Foundation Module - February 14th

Purpose: Rankin Inlet elders (including three members of the KEAC) participated in the Cultural Foundation Module of the Leadership Development Program by providing cultural insights through story telling.

Outcome: Following the elders prayer, participants shared a meal consisting of traditional 'country food including Arctic Char, Caribou and Baluga Whale.

The Elders, each in turn, shared their experiences living and growing up in Rankin. We heard of life before the Nickel Mine, how life changed through colonization and integration to working at the Nickel Mine, and just life in general within the community. They shared tales of hunting and fishing, gathering eggs and berries from the land, and even igloo building and what that was like to raise a family in. The Elders shared how life changed through the years before, during and after the Nickel Mine.

We also heard about their thoughts on the land claim agreement, the advance of technology, living through covid, and how they look forward to the next proposal for the extension of the Meliadine mine.

They expressed how the jobs and economy generated from the mine were important and desirable for them and their children and grandchildren.

Inuktitut name designation for the Kivalliq Elder Advisory Committee - June 6th


